Guest Speaker Ms. Tara Anchel Assistant Director of the Arrowsmith School On The Subject of Neuroplasticity

The Annual General Meeting is being called to elect Trustees to fill vacancies on the Board, to review the Financial Statements of the previous year and to conduct necessary business.

After the AGM, we will be very pleased to welcome an address on the developing world of Neuroplasticity.

Barbara Arrowsmith-Young was born with severe learning disabilities. Undaunted, she used her few strengths to develop brain exercises to conquer her neurological deficits and went on to create a program of brain building exercises that are offered in schools throughout Canada and USA. At the core of her Program is the principle of *neuroplasticity*, the capacity of neurons to alter structure and function in response to training and experience over a person's lifetime.

Tara Anchel, a special education teacher, discovered the work of Arrowsmith and how it was applying the principles of *neuroplasticity* to effect measurable and meaningful change in the lives of struggling students. This changed her understanding of learning disabilities, and of human potential, witnessing remarkable change in the lives of her students.

Tara will introduce the history and science behind the Arrowsmith Program – including common learning struggles and how they can be understood through a cognitive lens, demonstrating how Arrowsmith exercises are targeting weak brain areas to transform one's ability to learn.

At the conclusion of Ms. Anchel's talk, there will be a Question and Answer session, followed by refreshments. It will be an opportunity to meet the speaker, and share ideas with other FAMS members, the Board and Volunteers.

Recent Events

After 54 years of operating as a memorial society, the acceptance of simple, dignified and inexpensive funerals is becoming mainstream. Regulations are finally being brought into force on July 1, 2012. Most of the principles of transparency and fairness for consumers, promoted by memorial societies, have been incorporated into legislation after 11 years of hard and persistent work by the Legislation Committee of FOOMS-FCA.

We are now moving into a new phase of the memorial society movement, but we must remain vigilant to prevent any incursions into our rights as consumers. We don't want to return to having less consumer protection for funerals than in buying used cars.

This year, FAMS welcomed the members of the Funeral Advisory and Memorial Society of Peterborough and District into our midst. Your Board of Trustees, after careful consideration, agreed to assume administration of the Peterborough Society on November 15, 2011. The society's remaining assets were transferred to FAMS on that date. As is happening in many communities, the Peterborough society found that volunteers for its board and other activities became so few that the board could no longer carry on. FAMS' telephone and e-mail volunteers have been hearing from Peterborough members, many of whom have sent in donations to continue our work, for which we are most grateful.

FAMS, too, is struggling with an insufficiency of volunteers/board members. We urge members to give serious consideration to volunteer with FAMS. For retired persons, it's stimulating to get involved in work that is meaningful. For the newly retired, use your business skills or lose them! Legislation Update:

Good News for Consumers

After 11 years of concerted action by the Legislation Committee of the Federation of Ontario Memorial Societies — Funeral Consumers Alliance (FOOMS-FCA), the Funeral, Burial and Cremation Services Act and Regulation will take effect on July 1, 2012.

Some of the benefits for consumers are:

- Requiring
- More disclosure of information about consumers' rights and obligations.
- All prepaid contracts be guaranteed.
- More specific detail on contracts (the same description and prices of goods and services as on the price lists).
 - There must be disclosure of any financial connection with another firm, and if any benefit will be received from recommendation of a specific firm or insurance provider.
- Disclosure to the consumer if the person they are dealing with is a commissioned sales person.
- An operator must provide all contracted services at the time of need without making any additional charge.
- Restricting industry access to prepaid trust funds to 10% up to a maximum of \$350; this also applies to cancellation of a contract.
- Giving consumers the right to know if the business they are dealing with is properly licensed and if that business or person they are dealing with has had disciplinary action taken against them (previously there was no access to this information)
- Permitting Class 1 Transfer Services to offer further services to clients.
- Extending the 30 day "cooling off" period to the purchase of interment rights.
- Permitting consumers to resell interment rights.
- Requiring cemeteries to repurchase interment rights at market value, less the percentage retained for care and maintenance.

Putting off choosing a funeral home/transfer service and completing the FAMS funeral preplanning form is easily done. But, you'll be doing your family or those responsible for your arrangements a big favour by consulting with them and completing the form before need. A Film and a Book

Death and funerals are the subjects of two recent outstanding works of art and scholarship. <u>Departures</u> is the title of a Japanese film that won the award for best foreign film at the Oscars in 2009. It is a sensitive semi-comedy based on the silent, hands-on-Japanese ceremony of preparing the dead body, in full view of the family, before the final moment of cremation.

The young man at the centre of the story must not only learn how to perform this ceremony, but also overcome the social odium attached to any treatment of a corpse. The film ends with the words of the man whose job it is to light the flames for cremation — that he is simply sending these bodies to the next stage of their existence.

That "next stage" becomes for those who died in nineteenth-century Ontario, A Better Place, which is the title of a new book by Susan Smart, a social historian endowed with the skill to weave anecdote and quotation into her central themes of burials and funerals. Two strong points stand out in the book. One is the insight into local records, whether of small towns or of the cemeteries of Toronto; the other is the context of rural Ontario within the larger continental scene as the author reaches back into American books on funeral customs and manners that extended across the border to the middle classes of Ontario towns. Whether viewing the film or reading the book, make for an enjoyable learning both experience.
